## **Application to Transfer Ownership of an Exclusive Right of Burial Notes**

If the deceased is **not** the owner of the Exclusive Right of Burial Grant to the grave, an Application to Transfer Ownership of an Exclusive Right of Burial form must be completed. This will be necessary before the re-opening of a grave or before permission to erect a memorial can take place. A charge will be made for the transfer.

The applicant must attach applicable documents listed in section 7 of the form these are:

# Form of Assignment

Where the owner of the grave has assigned the grave to their next of kin.

#### **Grant of Probate / Will**

Where there is a will exceeding £5,000 in total assets.

If the deceased's estate is below £5,000, and does not contain any land, property, or shares, then it may be possible to deal with it without obtaining a grant. Also, a grant might not be needed if the whole of the estate is held in joint names and passes automatically to the surviving joint owner.

#### **Letters of Administration**

The deceased has not left a will and the estate has a value exceeding £5,000.

### **Statutory Declaration**

The next of kin declare that the deceased died without making a will and that they are entitled to take ownership of the grave. The Town Council can provide this form to the applicant and adapt it to their requirements.

Statutory Declarations must be witnessed by a Commissioner for Oaths (Solicitor) or a Magistrate.

#### Form of Renunciation

This form must be completed if there is more than one heir and must accompany the Statutory Declaration if applicable. Only one heir can take ownership of the grave. The Town Council can provide this form to the applicant and adapt it to their requirements.
